ORDER

Whereas the pay scale of ₹ 1800-3200 w.e.f. 1.1.1986 to 31.12.1995, has been allowed to the Petitioners in compliance of the order dated 22.7.2010 passed by Hon'ble High Court of Himachal Pradesh in CWP (T) No. 7171 of 2008 (OA No. 117/2005) titled Shri Mohinder Kumar and Ors versus State of H.P. and Others.

2. Whereas due to implementation of the order dated 22.7.2010 passed by Hon'ble High Court in respect of Petitioners, various aspects of the case were considered. In certain Departments, the pay scale of ₹ 1650-2925 was allowed w.e.f. 1.1.1986 which was revised to ₹ 5800-9200 w.e.f. 1.1.1996, whereas in certain Departments the same was revised to ₹ 5480-8925.

3. Whereas the State Government, with a view to bring uniformity and to remove the anomaly in the pay scales of the Statistical Assistants working in various Departments, who were not petitioners to the above cited CWP (T), has decided to allow the revised pay scale as under to all Statistical Assistants working in various Departments of the Government, provided the qualifications are similar as prescribed for identical level in the Department of Economics and Statistics. In view of the principle laid down by the Hon'ble Supreme Court of India in the matter of Shri Jai Dev Gupta Versus State of Himachal Pradesh (AIR 1998 SC. 2819), the aforesaid pay scale shall be allowed to such officials only on a notional basis from the due date. They may be given notional benefit of annual increments and their pay fixed accordingly. The actual monetary
