No. FIN-(PR)B(7)-1/98-II Dated Shimla-171002, the 31st May, 2001.

In exercise of the powers conferred by proviso to Article 309 of the Constitution of India and proviso to sub rule (1) of rule 10 of the Vidhan Sabha (Recruitment and Condition of Service) Rules, 1974, the Governor, Himachal Pradesh, is pleased to make the following rules to further amend the Himachal Pradesh Civil Services (Revised Pay) Rules, 1998 notified vide this Department Notification of even number dated 20th January, 1998, namely :-

1. (i) These rules may be called the Himachal Pradesh Civil Services (Revised Pay) (Third Amendment) Rules, 2001.
- (ii) They shall be deemed to have come into force from the First day of January, 1996.
3. In the second Schedule to Himachal Pradesh Civil Services (Revised Pay) First Amendment Rules, 1998 :

sanctioning typewriting allowance a certificate to the effect that the concerned Clerks were actually deployed on typing work from head of Office will be required every month.

The designation and revised equivalent of the un-revised pay scale of officials working as Senior Clerks and Junior Assistants as on 1st January, 1996 as noted in Col. 4 shall be protected as a measure personal to them. For future the total number of posts of Clerks including Senior Clerks and Junior Assistants in a cadre existing on 1st January, 1996 shall be bifurcated into the posts of Clerks in the pay scale of Rs. 3120-5160 (with initial start of Rs. 3220/-) and Junior Assistant in the pay scale of Rs. 4400-7000 in the ratio of 50:50.

The posts of Junior Assistant shall be filled up by placement to the extent of 100% out of the Clerks who have an experience of working as such for a minimum period of five years in the cadre of the department in which he is working at the time of placement.

Arrears on this account upto 31st May, 2001 would be credited to the General Provident Fund account of the concerned employees. The employees who have retired or ceased to be in govt. service or had closed their GPF accounts before issue of this letter or who might have closed their account by the time the arrears are credited to GPF shall be paid in cash.
