

**XV. THE PARTICULARS OF FACILITIES AVAILABLE TO CITIZENS FOR OBTAINING INFORMATION, INCLUDING THE WORKING HOURS OF THE LIBRARY OR READING ROOM, IF MAINTAINED FOR PUBLIC USE.**

The Public can access information about the status of their requests pertaining to enquiries of complaints, investigation of cases, verifications, permissions etc. at the following locations against the concerned units, as these offices being declared as PIOs. They can also see the various Acts/ Rules/ Govt Instructions/ Standing orders applicable to HP Police with these concerned PIOs located at their respective premises/ locations.

This facility shall be available on all working days during office hours (10.00 a.m to 1.30 p.m and 2.00 to 5.00 p.m).
